MTBC STAFF SPONSORSHIP INFORMATION

This information page will assist you in understanding how the sponsorship program works and what information and procedures need to be followed.

STAFF

- If accepted as a *Compensated* staff member of Mount Traber you will receive a "per week" compensation for the weeks you serve our Lord at camp. The number of weeks and weekly amount is subject to change as our needs change based on camper registration, staff positions being fulfilled satisfactorily and as funds are available.
- While at camp you will receive free board and lodging valued at \$40.00 per week.
- Once accepted and invited to attend pre-camp training, you will be approved to raise weekly sponsorship to assist
 with your compensation. Your time working at Mount Traber Bible Camp is considered a short-term mission.
- Your sponsorship is a donation to Mount Traber Bible Camp / BCM International Canada and therefore if for any
 reason you cannot complete this mission, any remaining funds will be applied towards mission staffing subsidies.
- All donated money towards your sponsorship is subject to employee deductions as required by Revenue Canada. The employers' portion required by Revenue Canada will be deducted from your sponsorship monies as well.
- Please Note: The chart below indicates the <u>maximum</u> amount of compensation that you can receive, including any salary being paid to you.
- Utilize the Sponsorship Form by:
 - 1. Filling in the "Staff Info" section
 - 2. Making photocopies for distribution and mailing
 - 3. Contacting your church mission board, family members, relatives and friends about your plans for a summer mission and your need for sponsorship
 - 4. Include a personal note about your service this summer
- Have all completed sponsorship forms and cheques forwarded to the Camp office.
- Paychecks are completed at the end of summer.
- All sponsorship donations are eligible for, and will receive a tax-deductible donation receipt. Compensation rates and sponsorship levels information is available on our Staff Sponsorship Information sheet.
- You do not receive any compensation for attending pre-camp as this is a training week however, you can raise sponsorship for this week.
